The group includes 24 females and 12 males. There are 8 modules covering topics such as communication, managing conflict, performance, health & safety, stress management, customer service etc. The goal is to develop workplace champions to enhance our

workplace culture and service delivery as well as provide personal growth, development and support our employees.
